- The HR team is preparing for Workday go-live on January 7, 2019. To support the requirements of cutover from Oracle to Workday, which begins November 30, there will be changes to your Oracle responsibilities. **Beginning on November 19 the above responsibilities in Oracle will end. You will maintain any Viewer responsibilities that you currently hold. If you do not currently hold a Viewer responsibility, you will be granted HRMS Viewer.**
- Note that Labor Distribution is not changing – it will continue to be completed in Oracle – and LD responsibilities in Oracle Finance will not change.
- All HR transactions that need to be completed in Oracle can be accomplished by contacting the HR Solution Center, 434-243-3344 or AskHR@virginia.edu. If you have questions or need support, your HR Business Partner can also assist you.
- Jobs@ will not turn off until May probably, will be used on case-by-case bases as far as moving to Workday.
- Applications will not migrate over, will still be accessible in Jobs@, employees should download them. Temporary workers will need to reapply in Workday, but not others, such as Faculty and UStaff.

- From December 15, 2018 through January 7, 2019, required online training for access to the Integrated System will not be available. The following are important dates to note as we

transition from Oracle Learning Management to Workday for access to online training and to enroll in instructor-led classes:

- Oracle Learning Management (Employee Self-Service > Learning) will be unavailable beginning Saturday, December 15, 2018. This means you will not be able to complete or have access to online training, and you will not be able to enroll in courses.
- The new learning management system in Workday will be available beginning Monday, January 7, 2019. All courses **completed** within the last 7 years will be listed in your **Learning** application; incomplete courses will not be listed.
- If you have an open ESHARP request, or need to complete any other online training, please complete it by December 15, 2018.
- If you need to enroll in Finance Fundamentals scheduled for January 8 or January 22, please do so by December 15, 2018. If you miss this date, please email FOC-training@virginia.edu with the name of the enrollee. No other instructor-led classes are open for enrollment at this time, but will be in Workday after January 7, 2019.
