The change became effective March 14, 2018 and more effectively aligns resources and priorities to achieve future institutional goals.

- Treasury is making a change to the language of the Monitoring of Cash Balances and Resolving Deficits in Revenue Projects (FIN-033) policy to include balance sheet accounts. The intention was always to include these accounts, therefore, we're updating the policy to reflect this intention more clearly. This will also bring the policy more in-line with the account reconciliation procedures.

- New Student Payment Portal
  - Moving to a new Student Payment portal called UVAPay. Many of you are familiar with QuickPay, which is being retired after 10 years of service.
  - Our students, parents or other family members who have been designated as Authorized Payers will start using UVAPay for student payments and semester payment plans Thursday, May 17.
  - Students and Authorized Payers will be able to use UVAPay to view their student account activity, make payments, get account statements, and set up semester payment plans. As with QuikPay, students will be able to access UVAPay through SIS, and Authorized Payers will have their own log-in page.
  - Communications were sent to students and authorized payers in early spring. However, additional communications will go out to all current student and authorized payers tomorrow morning.
